# **NATURE OF ACTION**

1. This lawsuit is brought as a proposed class action against Defendants DENSO Corporation, DENSO International America, Inc. (together, "Denso Defendants" or "DENSO"), Ichikoh Industries, Ltd. ("Ichikoh"); Panasonic Corporation and Panasonic Corporation of North America (together, the "Panasonic Defendants" or "Panasonic"), Stanley Electric Co., Ltd., Stanley Electric U.S. Co., Inc., II Stanley Co., Inc. (together, the "Stanley Electric Defendants" or "Stanley"), Koito Manufacturing Co., Ltd., North American Lighting, Inc. (together, the "Koito Defendants" or "Koito"), Mitsubishi Electric Corporation, Mitsubishi Automotive

America, Inc., Mitsubishi Electric US Holdings, Inc. (together, the "Mitsubishi Defendants" or "Mitsubishi") (collectively, "Defendants"), and unnamed co-conspirators, manufacturers and/or suppliers of automotive high intensity discharge ballasts (referred to herein as "HID Ballasts" and as defined below) for engaging in a long-running conspiracy to unlawfully fix, artificially raise, maintain and/or stabilize prices, rig bids for, and allocate the market and customers in the United States for HID Ballasts.

- 2. Plaintiffs seek to represent all persons and entities who, during the period from and including July 1, 1998 through such time as the anticompetitive effects of the Defendants' conduct ceased (the "Class Period"), purchased or leased a new vehicle in the United States not for resale which included one or more HID Ballast(s) as a component part, or indirectly purchased one or more HID Ballast(s) as a replacement part, which were manufactured or sold by the Defendants, any current or former subsidiary of the Defendants or any co-conspirator of the Defendants.
- 3. An "HID Ballast" is an electrical device that limits the amount of electrical current flowing to an HID headlamp, which would otherwise rise to destructive levels due to the HID headlamp's negative resistance.
- 4. The Defendants manufacture, market, and sell HID Ballasts throughout and into the United States. The Defendants and other co-conspirators (as yet unknown) agreed, combined and conspired to fix, raise, maintain and/or stabilize prices, and allocate market shares for HID Ballasts.
- 5. The U.S. Department of Justice's ("DOJ") Antitrust Division is currently conducting a broad criminal investigation into illegal price-fixing and bid-rigging in the automotive parts industry. As part of its criminal investigation, the DOJ is seeking information

about unlawful anticompetitive conduct in the market for a number of different but related automotive parts, and the Federal Bureau of Investigation ("FBI") has participated in raids, pursuant to search warrants, carried out in the offices of a number of major competitors in the automotive parts industry. The automotive parts investigation is the largest criminal investigation the Antitrust Division has ever pursued, both in terms of its scope and the potential volume of commerce affected by the allegedly illegal conduct. The ongoing cartel investigation of price-fixing and bid-rigging in the automotive parts industry has yielded approximately \$2.3 billion in criminal fines.

- 6. On July 18, 2013, the DOJ announced that Panasonic Corporation agreed to plead guilty and pay a \$45.8 million criminal fine for its role in a conspiracy to fix prices of automotive parts, including HID Ballasts, installed in automobiles sold in the United States and elsewhere.
- 7. On September 26, 2013 the DOJ announced that Defendant Mitsubishi Electric Corporation had agreed to plead guilty and to pay a \$190 million criminal fine for their role in a conspiracy to rig bids for, and to fix, stabilize and maintain prices of certain automotive parts installed in automobiles manufactured and sold in the United States and elsewhere.
- 8. Defendant Mitsubishi Electric Corporation's guilty plea defines automotive parts to include, among other parts, HID ballasts. Pursuant to its guilty plea, Defendant Mitsubishi Electric Corporation and its subsidiaries have pledged to cooperate in the DOJ's automotive parts investigation, including with respect to HID Ballasts. Mitsubishi Electric Corporation's guilty plea further provides that in exchange for it and its subsidiaries cooperation in the DOJ's automotive parts investigation, including with respect to HID Ballasts, the DOJ will refrain from

criminally prosecuting Mitsubishi Electric Corporation and its subsidiaries for price-fixing certain automotive parts, including HID Ballasts.

- 9. On November 27, 2013, the DOJ announced that Stanley Electric Co., Ltd. agreed to plead guilty and pay a \$1.44 million criminal fine for its role in a conspiracy to fix prices of HID Ballasts installed in automobiles sold in the United States and elsewhere.
- 10. On January 16, 2014, the DOJ announced that Koito Manufacturing Co., Ltd. agreed to plead guilty and pay a \$56.6 million criminal fine for its role in a conspiracy to fix prices of automotive parts, including HID Ballasts, installed in automobiles sold in the United States and elsewhere.
- 11. Competition authorities in Japan and possibly elsewhere, have also been investigating a conspiracy in the market for various automotive parts since at least July 2011 and the Japanese Fair Trade Commission ("JFTC") has raided the offices of Stanley Electric Co., Ltd. and Koito. The European Commission Competition Authority ("EC") has also conducted dawn raids at the European offices of several automotive parts manufacturers.
- 12. The Defendants and their co-conspirators participated in a combination and conspiracy to suppress and eliminate competition in the automotive parts industry by agreeing to rig bids for, and to fix, stabilize, and maintain the prices of HID Ballasts sold to automobile manufacturers and others in the United States. The combination and conspiracy engaged in by the Defendants and their co-conspirators was in unreasonable restraint of interstate and foreign trade and commerce in violation of the Sherman Antitrust Act, 15 U.S.C. § 1, and state antitrust, unfair competition and consumer protection laws.

- 13. By way of example, representatives from Defendants DENSO, Ichikoh, Panasonic, Stanley, Koito, and Mitsubishi attended and participated in at least six meetings with together in which they discussed pricing of HID Ballasts.
- 14. During these meetings, DENSO entered into agreements with Defendants to "respect" Defendants' core customers, i.e., refrain from taking their business. In return Defendants pledged to "respect" DENSO's core customers, including Toyota.
- 15. As a direct result of the anti-competitive and unlawful conduct alleged herein,
  Plaintiffs and the Classes (as defined below) paid artificially inflated prices for HID Ballasts
  during the Class Period and have thereby suffered antitrust injury to their business or property.

# **JURISDICTION AND VENUE**

- 16. Plaintiffs bring this action under Section 16 of the Clayton Act (15 U.S.C. § 26) to secure equitable and injunctive relief against the Defendants for violating Section 1 of the Sherman Act (15 U.S.C. § 1). Plaintiffs also assert claims for actual and exemplary damages pursuant to state antitrust, unfair competition and consumer protection laws, and seek to obtain restitution, recover damages and secure other relief against the Defendants for violations of those state laws. Plaintiffs and the Classes also seek attorneys' fees, costs, and other expenses under federal and state law.
- 17. This Court has jurisdiction over the subject matter of this action pursuant to Section 16 of the Clayton Act (15 U.S.C. § 26), Section 1 of the Sherman Act (15 U.S.C. § 1), and Title 28, United States Code, Sections 1331 and 1337. This Court has subject matter jurisdiction of the state law claims pursuant to 28 U.S.C. §§ 1332(d) and 1367, in that: (i) this is a class action in which the matter or controversy exceeds the sum of \$5,000,000, exclusive of interests and costs, and in which some members of the proposed Classes are citizens of a state

different from the Defendants; and (ii) Plaintiffs' state law claims form part of the same case or controversy as their federal claims under Article III of the United States Constitution.

- 18. Venue is proper in this District pursuant to Section 12 of the Clayton Act (15 U.S.C. § 22), and 28 U.S.C. §§ 1391 (b), (c), and (d), because a substantial part of the events giving rise to Plaintiffs' claims occurred in this District, a substantial portion of the affected interstate trade and commerce discussed below has been carried out in this District, and the Defendants reside, are licensed to do business in, are doing business in, had agents in, or are found or transact business in this District.
- 19. This Court has *in personam* jurisdiction over the Defendants because the Defendants, either directly or through the ownership and/or control of their subsidiaries, *inter alia*: (a) transacted business in the United States, including in this District; (b) directly or indirectly sold or marketed substantial quantities of HID Ballasts throughout the United States, including in this District; (c) had substantial aggregate contacts with the United States as a whole, including in this District; or (d) were engaged in an illegal price-fixing conspiracy that was directed at, and had a direct, substantial, reasonably foreseeable and intended effect of causing injury to the business or property of persons and entities residing in, located in, or doing business throughout the United States, including in this District. The Defendants also conduct business throughout the United States, including in this District, and have purposefully availed themselves of the laws of the United States.
- 20. The Defendants engaged in conduct both inside and outside of the United States that caused direct, substantial and reasonably foreseeable and intended anticompetitive effects upon interstate commerce within the United States.

- 21. The activities of the Defendants and their co-conspirators were within the flow of, were intended to, and did have, a substantial effect on interstate commerce of the United States.

  The Defendants' products are sold in the flow of interstate commerce.
- 22. HID Ballasts manufactured abroad by the Defendants and sold for use in automobiles in the United States are goods brought into the United States for sale, and therefore constitute import commerce. To the extent any of HID Ballasts are purchased in the United States, and such HID Ballasts do not constitute import commerce, the Defendants' unlawful activities with respect thereto, as more fully alleged herein during the Class Period, had, and continue to have, a direct, substantial and reasonably foreseeable effect on United States commerce. The anticompetitive conduct, and its effect on United States commerce described herein, proximately caused antitrust injury to Plaintiffs and members of the Classes in the United States.
- 23. By reason of the unlawful activities hereinafter alleged, the Defendants substantially affected commerce throughout the United States, causing injury to Plaintiffs and members of the Classes. The Defendants, directly and through their agents, engaged in activities affecting all states, to fix, raise, maintain and/or stabilize prices, rig bids and allocate the market and customers in the United States for HID Ballasts, which conspiracy unreasonably restrained trade and adversely affected the market for HID Ballasts.
- 24. The Defendants' conspiracy and wrongdoing described herein adversely affected persons in the United States who purchased HID Ballasts not for resale, including Plaintiffs and members of the Classes.

- 84. Defendant DENSO International America, Inc. is a Delaware corporation with its principal place of business in Southfield, Michigan. It is a subsidiary of and wholly owned and/or controlled by its parent, DENSO Corporation. DENSO International America, Inc. directly and/or through its subsidiaries, which it wholly owned and/or controlled manufactured, marketed, and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period. According to DENSO's website, DENSO International America, Inc. is "DENSO's North American regional headquarters and parent company for its North American operations, original equipment (OE) sales, product engineering and technical support to OE sales and finance."
- 85. Defendant Ichikoh is a Japanese corporation with its principal place of business in Kanagawa-ken, Japan. Ichikoh directly and/or through its subsidiaries, which it wholly owned

and/or controlled – manufactured, marketed and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period. Ichikoh's main customers include Toyota, Subaru, Nissan and Honda.

- 86. Defendant Panasonic Corporation is a Japanese company with its principal place of business in Osaka, Japan. Panasonic Corporation directly and/or through its subsidiaries, which it wholly owned and/or controlled manufactured, marketed and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period.
- 87. Defendant Panasonic Corporation of North America is a Delaware corporation with its principal place of business in Secaucus, New Jersey. It is a subsidiary of and wholly owned and/or controlled by its Japanese parent, Panasonic Corporation. Panasonic Corporation of North America manufactured marketed and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period. Specifically, Panasonic Automotive Systems Company of America, a registered assumed name of Panasonic Corporation of North America, is a division of Panasonic Corporation of North America and supplies automotive parts, including HID Ballasts, to the North America automotive industry. Panasonic Automotive Systems Company of America is headquartered in Peachtree City, Georgia, and has its main sales office in Farmington Hills, Michigan.
- 88. Defendant Stanley Electric Co., Ltd. is a Japanese corporation with its principal place of business in Tokyo, Japan. Stanley Electric Co., Ltd. directly and/or through its subsidiaries, which it wholly owned and/or controlled manufactured, marketed and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period. In 2011, Stanley had net sales of \$2.98 billion, including net sales in North America of \$396.4 million.

- 89. Defendant Stanley Electric U.S. Co., Inc. is an Ohio corporation with its principal place of business in Ohio. It is a subsidiary of and wholly-owned and/or controlled by its parent, Stanley Electric Co., Ltd. Stanley Electric U.S. Co., Inc. manufactured, marketed, and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period.
- 90. Defendant II Stanley Co., Inc. is a Michigan corporation with its principal place of business in Michigan. It is a subsidiary of and wholly-owned and/or controlled by its parent, Stanley Electric Co., Ltd. II Stanley Co., Inc. manufactured, marketed, and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period.
- 91. Defendant Koito Manufacturing Co., Ltd. is a Japanese corporation with its principal place of business in Tokyo, Japan. Koito Manufacturing Co., Ltd. directly and/or through its subsidiaries, which it wholly owned and/or controlled manufactured, marketed and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period. In 2011, Koito Manufacturing Co., Ltd. had net sales of \$5.16 billion, including net sales in North America of \$550 million.
- 92. Defendant North American Lighting, Inc. is a Michigan corporation with its principal place of business in Illinois. It is a subsidiary of and wholly-owned and/or controlled by its parent, Koito Manufacturing Co., Ltd. North American Lighting, Inc. manufactured, marketed, and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period.
- 93. Defendant Mitsubishi Electric Corporation is a Japanese corporation with its principal place of business in Tokyo, Japan. Mitsubishi Electric Corporation —directly and/or

through its subsidiaries, which it wholly owned and/or controlled—manufactured, marketed and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period.

- 94. Defendant Mitsubishi Electric US Holdings, Inc. is a Delaware corporation with its principal place of business in Cypress, California. It is a subsidiary of and wholly owned and/or controlled by its parent, Mitsubishi Electric Corporation. Mitsubishi Electric US Holdings, Inc. directly and/or through its subsidiaries, which it wholly owned and/or controlled manufactured, marketed and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period.
- 95. Defendant Mitsubishi Electric Automotive America, Inc. is a Delaware corporation with its principal place of business in Mason, Ohio. It is a subsidiary of and wholly owned and/or controlled by its parent, Mitsubishi Electric US Holdings, Inc. Mitsubishi Electric Automotive America, Inc. manufactured, marketed and/or sold HID Ballasts that were purchased throughout the United States, including in this District, during the Class Period.

## AGENTS AND CO-CONSPIRATORS

- 96. Each Defendant acted as the principal of or agent for the other Defendant with respect to the acts, violations, and common course of conduct alleged herein.
- 97. Various persons, partnerships, sole proprietors, firms, corporations and individuals not named as defendants in this lawsuit, and individuals, the identities of which are presently unknown, have participated as co-conspirators with the Defendants in the offenses alleged in this Complaint, and have performed acts and made statements in furtherance of the conspiracy or in furtherance of the anticompetitive conduct.

98. Whenever in this Complaint reference is made to any act, deed or transaction of any corporation or limited liability entity, the allegation means that the corporation or limited liability entity engaged in the act, deed or transaction by or through its officers, directors, agents, employees or representatives while they were actively engaged in the management, direction, control or transaction of the corporation's or limited liability entity's business or affairs.

# **FACTUAL ALLEGATIONS**

# A. The HID Ballasts Industry

99. An HID Ballast is an electrical device that limits the amount of electrical current flowing to an HID headlamp, which would otherwise rise to destructive levels due to the HID headlamp's negative resistance. An HID Ballast manufactured by the Panasonic Defendants is shown below.





- 100. HID Ballasts are installed by original equipment manufacturers ("OEMs") in new cars as part of the automotive manufacturing process. They are also installed by OEMs in cars to replace worn out, defective or damaged HID Ballasts.
- 101. For new cars, the OEMs—mostly large automotive manufacturers such as Toyota, Mazda and Nissan —purchase HID Ballasts directly from the Defendants. HID Ballasts may also be purchased by component manufacturers who then supply such systems to OEMs. These component manufacturers are also called "Tier 1 Manufacturers" in the industry. Tier 1 Manufacturers supply HID Ballasts directly to an OEM.
- 102. When purchasing HID Ballasts, OEMs issue Requests for Quotation ("RFQs") to automotive parts suppliers on a model-by-model basis for model specific parts. Automotive parts suppliers submit quotations, or bids, to OEMs in response to RFQs, and the OEMs usually award the business to the selected automotive parts supplier for the lifespan of the model, which is usually four to six years. Typically, the bidding process for a particular model begins approximately three years prior to the start of production of a new model. OEMs procure parts for U.S.-manufactured vehicles both in Japan and the United States.

- 103. The Defendants and their co-conspirators supplied HID Ballasts to OEMs for installation in vehicles manufactured and sold in the United States and elsewhere. The Defendants and their co-conspirators sold HID Ballasts (a) in the United States and elsewhere for installation in vehicles manufactured and sold in the United States, (b) in Japan and elsewhere for export to the United States and installation in vehicles manufactured and sold in the United States, and (c) in Japan and elsewhere for installation in vehicles manufactured in Japan, some of which were then exported to and sold in the United States..
- 104. Plaintiffs and members of the proposed Classes purchased HID Ballasts indirectly from the Defendants. By way of example, an owner of a vehicle may indirectly purchase one or more HID Ballast(s) from the Defendants as part of purchasing or leasing a new vehicle. An owner of a vehicle may also indirectly purchase for replacement one or more HID Ballast(s) from the Defendants when repairing a damaged vehicle or where one or more of the vehicle's HID Ballasts are defective.

# B. Defendants Increased Prices for HID Ballasts in the Face of Declining Demand During the Class Period

- 105. The Producer Price Index ("PPI") measures the average change over time in the prices received by domestic producers for their output. The chart below (see Figure 1) provides a 1998-2012 illustration of vehicular lighting equipment pricing. Because HID Ballasts are part of a vehicle's lighting equipment, the PPI for vehicular lighting equipment is a good indicator of the change over time in the prices received by domestic producers of HID Ballasts.
- 106. The PPI for vehicular lighting equipment indicates that the prices for HID Ballasts generally held steady or increased during the Class Period.



107. Meanwhile, according to data from Bloomberg, demand for automobiles in the United States generally decreased during the same period. From 2007 to 2009, at the height of the recession, the auto industry experienced a very significant 35% drop in demand. *See* Figure 2. The PPI for vehicle electrical and electronic equipment for the very same time period indicates that prices for HID Ballasts increased. According to the law of supply and demand, prices during this period should have fallen, but instead they increased (*see* Figure 1).



- 108. In a competitive market, falling demand would lead to decreased prices because competitors would need to lower prices in order to attract customers and increase demand. In a market where competitors have engaged in a conspiracy to fix prices, however, competitors do not lower prices even when faced with decreasing demand. Such price decreases are unnecessary because the conspirators know that they will not lose sales to lower priced competitors.
- 109. The price of vehicle electrical and electronic equipment and by extension HID Ballasts increased during the Class Period, even during periods when demand decreased. In a competitive market, falling or steady demand should not have resulted in rising (*see* the 2004-

2007 period in Figure 1 as well) prices for HID Ballasts. Such anticompetitive price increases have resulted in Plaintiffs and members of the Classes paying supracompetitive prices.

# C. The Structure and Characteristics of the HID Ballasts Market Render the Conspiracy More Plausible

110. The structure and other characteristics of the HID Ballasts market in the United States are conducive to a price-fixing agreement, and have made collusion particularly attractive in this market. Specifically, the HID Ballasts market: (1) has high barriers to entry; and (2) has inelasticity of demand.

# 1. The HID Ballasts Market Has High Barriers to Entry

- 111. A collusive arrangement that raises product prices above competitive levels would, under basic economic principles, attract new entrants seeking to benefit from the supracompetitive pricing. Where, however, there are significant barriers to entry, new entrants are less likely. Thus, barriers to entry help to facilitate the formation and maintenance of a cartel.
- 112. There are substantial barriers that preclude, reduce, or make more difficult entry into the HID Ballasts market. A new entrant into the business would face costly and lengthy start-up costs, including multi-million dollar costs associated with manufacturing plants and equipment, energy, transportation, distribution infrastructure, and long-standing customer relationships.
- 113. Defendants own several patents related to the manufacture of HID Ballasts.

  These patents place a significant and costly burden on potential new entrants, who must avoid infringing on the patents when entering the market with a new product.
- 114. In addition, OEMs cannot change HID Ballasts suppliers randomly after a supplier is initially selected because the OEMs design the features of their vehicles so that HID Ballasts they purchase for a vehicle are then integrated with the electronics, mechanics and other

features of the particular vehicle model. Thus, the design must be synergized by HID Ballasts manufacturers and OEMs. It would be difficult for a new market entrant to do so.

# 2. There is Inelasticity of Demand for HID Ballasts

- 115. "Elasticity" is a term used to describe the sensitivity of supply and demand to changes in one or the other. For example, demand is said to be "inelastic" if an increase in the price of a product results in only a small decline in the quantity sold of that product, if any. In other words, customers have nowhere to turn for alternative, cheaper products of similar quality, and so continue to purchase despite a price increase.
- 116. For a cartel to profit from raising prices above competitive levels, demand must be relatively inelastic at competitive prices. Otherwise, increased prices would result in declining sales, revenues, and profits, as customers purchased substitute products or declined to buy altogether. Inelastic demand is a market characteristic that facilitates collusion, allowing producers to raise their prices without triggering customer substitution and lost sales revenue.
- 117. Demand for HID Ballasts is highly inelastic because there are no close substitutes for these products. In addition, customers must purchase HID Ballasts as an essential part of a vehicle, even if the prices are kept at a supra-competitive level.

# **D.** Government Investigations

118. A globally coordinated antitrust investigation is taking place in the United States, Europe, and Japan, aimed at suppliers of automotive parts. A JFTC official told a leading legal publication that automotive parts supplier investigations by the JFTC, DOJ and EC would continue to widen because the automotive industry as a whole comprises many sub-industries. He characterized the investigations being conducted by the U.S., European and Japanese antitrust authorities as "large and broad," and he declined to deny that this "would be history's largest case."

- 119. In 2011, the JFTC began investigating various automotive parts manufacturers, probing allegations that these manufactures were allocating contracts to each other and to avoid competing for supply contracts with Honda, Nissan Motor Co., Ltd., Suzuki Motor Co. and Fuji Heavy Industries, Ltd., the owner of Subaru. The probe found that some of the automotive parts manufacturers had collusively agreed to split into varying groups for the differing purchasers and the different parts, including windshield wipers an automotive part closely related to Windshield Wiper Systems.
- 120. The JFTC raided offices of Defendants as part of the spreading investigation of suspected price-fixing of automotive parts. The companies raided included DENSO. According to its 2011 Annual Report, DENSO was investigated on July 20, 2011 at various locations, including in Kariya, Aichi and some other sales branches in Japan.
- 121. On November 22, 2012, the JFTC handed down fines totaling \$41.3 million against various automotive parts manufacturers. On November 22, 2012, the JFTC also announced cease-and-desist orders against the violating companies, requiring them to (i) immediately pass resolutions that they would terminate any illegal conduct; (ii) contact any automobile maker who may have purchased their parts through collusive bidding processes; and (iii) implement employee compliance programs. According to the JFTC, DENSO violated antitrust laws, but did not receive a cease-and-desist order.
- 122. The companies rigged the bidding process for supply contracts with automobile makers for automotive parts by pre-selecting the winners and losers. The JFTC explained that these companies "substantially restrained competition in the fields of each product ordered by each automobile company, by designating successful bidders."

- 123. Representatives from Defendants DENSO, Ichikoh, Panasonic, Stanley, Koito, and Mitsubishi attended and participated in at least six meetings together in which they discussed pricing of HID Ballasts.
- 124. During these meetings, DENSO entered into agreements with Defendants to "respect" Defendants' core customers, i.e., refrain from taking their business. In return Defendants pledged to "respect" DENSO's core customers, including Toyota.
- 125. On March 21, 2013, the JFTC announced that it had levied fines totaling \$49.1 million, including a \$13.1 million fine against Defendant Ichikoh for violating antitrust laws by forming a cartel to fix prices for automotive lamps. Certain automotive lamps, including those sold by Defendant Ichikoh, contain HID Ballasts as a component part.
- 126. On March 21, 2013 the JFTC also announced the imposition of cease-and-desist orders against Defendant Ichikoh, requiring it to (i) immediately pass resolutions that they would terminate any illegal conduct in the automotive ;amps industry, (ii) contact any automobile maker who may have purchased their Automotive Lamps through collusive bidding processes, (iii) refrain from engaging in such illegal conduct in the future, and (iv) implement employee antitrust compliance programs.
- 127. On July 18, 2013, the DOJ announced that Defendant Panasonic Corporation agreed to pay a \$45.8 million criminal fine and to plead guilty to a three-count criminal information charging it with participating in a combination and conspiracy to suppress and eliminate competition in the automotive parts industry by agreeing to rig bids for, and to fix, stabilize, and maintain the prices of automotive parts, including HID Ballasts, sold to Honda Motor Company, Ltd. and American Honda Motor Company, Inc. (collectively "Honda"), Mazda Motor Corporation and Mazda Motor of America, Inc. (collectively "Mazda"), and

Nissan Motor Company Ltd. and Nissan North America, Inc. (collectively "Nissan") for installation in vehicles manufactured and sold in the United States and elsewhere from at least as early as July 1998 and continuing until at least February 2010, in violation of the Sherman Act, 15 U.S.C. § 1.

- 128. According to the Information filed, Defendant Panasonic Corporation and its coconspirators carried out the HID Ballasts conspiracy by:
- (a) participating in meetings, conversations, and communications in Japan to discuss the bids and price quotations to be submitted to Honda, Mazda, and Nissan in the United States and elsewhere;
- (b) agreeing, during those meetings, conversations, and communications, on bids and price quotations to be submitted to Honda, Mazda, and Nissan in Japan;
- (c) agreeing, during those meetings, conversations, and communications, to allocate the supply of HID Ballasts sold to automobile manufacturers in the United States and elsewhere on a model-by-model basis;
- (d) agreeing, during those meetings, conversations, and communications, to coordinate price adjustments requested by Honda, Mazda, and Nissan in Japan;
- (e) submitting bids, price quotations, and price adjustments to Honda, Mazda and Nissan in Japan in accordance with the agreements reached;
- (f) selling HID Ballasts to Honda, Mazda, and Nissan in the United States and elsewhere at collusive and noncompetitive prices;
- (g) accepting payment for HID Ballasts sold to Honda, Mazda, and Nissan in the United States and elsewhere at collusive and noncompetitive prices;

- (h) engaging in meetings, conversations, and communications in Japan for the purpose of monitoring and enforcing adherence to the agreed-upon bid-rigging and price-fixing scheme; and
- (i) employing measures to keep their conduct secret, including using code names and choosing meeting places and times to avoid detection.
- 129. On September 26, 2013, the DOJ announced that Mitsubishi Electric Corporation agreed to plead guilty and to pay a \$190 million criminal fine for its role in a conspiracy to rig bids for, and to fix, stabilize, and maintain the prices of certain automotive parts sold to automobile manufacturers, including Ford Motor Company, General Motors LLC, Chrysler Group LLC, Fuji Heavy Industries Ltd., Nissan Motor Company Ltd., Honda Motor Company Ltd., and certain of their subsidiaries, in the United States and elsewhere from at least as early as January 2000 to and continuing to at least February 2010 in violation of the Sherman Antitrust Act, 15 U.S.C. § 1.
- 130. According to the Information filed, Defendant Mitsubishi Electric Corporation and its co-conspirators carried out the automotive parts conspiracy by:
- (a) participating in meetings, conversations, and communications in the United States and elsewhere to discuss the bids and price quotations to be submitted to automobile manufacturers in the United States and elsewhere;
- (b) agreeing, during those meetings, conversations, and communications, on bids and price quotations to be submitted to automobile manufacturers in the United States and elsewhere;

- (c) agreeing, during those meetings, conversations, and communications, to allocate the supply of certain automotive parts sold to automobile manufacturers in the United States and elsewhere;
- (d) agreeing, during those meetings, conversations, and communications, to coordinate price adjustments requested by automobile manufacturers in the United States and elsewhere;
- (e) submitting certain bids, price quotations, and price adjustments to automobile manufacturers in the United States and elsewhere in accordance with the agreements reached;
- (f) selling certain automotive parts to automobile manufacturers in the United States and elsewhere at collusive and noncompetitive prices;
- (g) accepting payment for certain automotive parts sold to automobile manufacturers in the United State and elsewhere at collusive and noncompetitive prices; and
- (h) engaging in meetings, conversations, and communications in the United States and elsewhere for the purpose of monitoring and enforcing adherence to the agreed-upon bid-rigging and price-fixing scheme; and
- (i) employing measures to keep their conduct secret, including, but not limited to, using code names and meeting at remote locations.
- 131. Mitsubishi Electric Corporation's guilty plea defines automotive parts to include, among other parts, HID ballasts. Pursuant to its guilty plea, Defendant Mitsubishi Electric Corporation and its subsidiaries have pledged to cooperate in the DOJ's automotive parts investigation, including with respect to HID Ballasts. Mitsubishi Electric Corporation's guilty plea further provides that in exchange for it and its subsidiaries' cooperation in the DOJ's

automotive parts investigation, including with respect to HID Ballasts, the DOJ will refrain from criminally prosecuting Mitsubishi Electric Corporation and its subsidiaries for price-fixing certain automotive parts, including HID Ballasts.

- 132. On November 27, 2013, the DOJ announced that Defendant Stanley Electric Co., Ltd. agreed to pay a \$1.44 million criminal fine and plead guilty to a one-count criminal information charging it with participating in a combination and conspiracy to suppress and eliminate competition in the automotive parts industry by agreeing to rig bids for, and to fix, stabilize, and maintain the prices of HID Ballasts sold to automobile manufacturers in the United States and elsewhere, from at least as early as July 1998 and continuing until at least February 2010, in violation of the Sherman Act, 15 U.S.C. § 1.
- 133. According to the Information filed, Defendant Stanley Electric Co., Ltd. and its co-conspirators carried out the HID Ballasts conspiracy by:
- (a) participating in meetings, conversations, and communications in Japan to discuss the bids and price quotations to be submitted to automobile manufacturers in the United States and elsewhere;
- (b) agreeing, during those meetings, conversations, and communications, on bids and price quotations to be submitted to certain automobile manufacturers;
- (c) agreeing, during those meetings, conversations, and communications, to allocate the supply of HID Ballasts sold to certain automobile manufacturers in the United States and elsewhere on a model-by-model basis;
- (d) agreeing, during those meetings, conversations, and communications, to coordinate price adjustments requested by certain automobile manufacturers in Japan;

- (e) submitting bids, price quotations, and price adjustments to certain automobile manufacturers in Japan in accordance with the agreements reached;
- (f) selling HID Ballasts to certain automobile manufacturers in the United States and elsewhere at collusive and noncompetitive prices;
- (g) accepting payment for HID Ballasts sold to certain automobile manufacturers in the United States and elsewhere at collusive and noncompetitive prices;
- (h) engaging in meetings, conversations, and communications in Japan for the purpose of monitoring and enforcing adherence to the agreed-upon bid-rigging and price-fixing scheme; and
- (i) employing measures to keep their conduct secret, including using code names and choosing meeting places and times to avoid detection.
- 134. According to the Plea Agreement filed January 23, 2014, Defendant Stanley Electric Co., Ltd. participated in an agreement to allocate the supply of, rig bids for, and to fix, stabilize, and maintain the prices, including coordinating price adjustments requested by purchasers, of HID Ballasts sold to Toyota Motor Corporation, Honda Motor Company, Ltd., Nissan Motor Co., Ltd., Fuji Heavy Industries, Ltd. (Subaru), Mazda Motor Corporation, and/or certain of their United States subsidiaries in the United States and elsewhere.
- 135. On January 16, 2014, the DOJ announced that Defendant Koito Manufacturing Co., Ltd. agreed to pay a \$56.6 million criminal fine and to plead guilty to a two-count criminal information charging it with participating in a combination and conspiracy to suppress and eliminate competition in the automotive parts industry by agreeing to rig bids for, and to fix, stabilize, and maintain the prices of automotive parts, including HID Ballasts, sold to automobile

manufacturers in the United States and elsewhere, from at least as early as July 1998 and continuing until at least February 2010, in violation of the Sherman Act, 15 U.S.C. § 1.

- 136. According to the Information filed, Defendant Koito Manufacturing Co., Ltd. and its co-conspirators carried out the HID Ballasts conspiracy by:
- (a) participating in meetings, conversations, and communications in Japan to discuss the bids and price quotations to be submitted to certain automobile manufacturers in the United States and elsewhere;
- (b) agreeing, during those meetings, conversations, and communications, on bids and price quotations to be submitted to certain automobile manufacturers;
- (c) agreeing, during those meetings, conversations, and communications, to allocate the supply of HID Ballasts sold to certain automobile manufacturers in the United States and elsewhere on a model-by-model basis;
- (d) agreeing, during those meetings, conversations, and communications, to coordinate price adjustments requested by certain automobile manufacturers in Japan;
- (e) submitting bids, price quotations, and price adjustments to certain automobile manufacturers in Japan in accordance with the agreements reached;
- (f) selling HID Ballasts to automobile manufacturers in the United States and elsewhere at collusive and noncompetitive prices;
- (g) accepting payment for certain HID Ballasts sold to automobile manufacturers in the United States and elsewhere at collusive and noncompetitive prices;
- (h) engaging in meetings, conversations, and communications in Japan for the purpose of monitoring and enforcing adherence to the agreed-upon bid-rigging and price-fixing scheme; and

(i) employing measures to keep their conduct secret, including using code names and choosing meeting places and times to avoid detection.

# E. Existence of a Cooperating Defendant

- 137. The Antitrust Criminal Penalty Enhancement and Reform Act ("ACPERA") provides leniency benefits for a participant in a price-fixing conspiracy that voluntarily discloses its conduct to the Department of Justice. In most recent cases in which guilty pleas for price-fixing conduct have been obtained, there has been a cooperating party that has been accepted into the DOJ's ACPERA program as an "amnesty applicant." One of the leniency benefits for a conspirator that is accepted into the ACPERA program is that it is not charged with a criminal offense and is not required to plead guilty to criminal charges.
- 138. In light of the guilty plea in this case, guilty pleas in related automotive parts antitrust cases and the DOJ's ongoing investigation into the industry, it is reasonable for this Court to infer that there is an ACPERA "amnesty applicant" in this case.

#### F. Guilty Pleas in Related Markets in the Automotive Industry

- 139. On September 29, 2011, the DOJ announced that Furukawa Electric Co. Ltd. had agreed to plead guilty and to pay a \$200 million criminal fine for its role in a criminal price-fixing and bid-rigging conspiracy involving the sale of automotive wire harnesses and related products to automobile manufacturers.
- 140. In the press release announcing the fine against Furukawa Electric Co. Ltd., Sharis A. Pozen, then the Acting Assistant Attorney General in charge of the Department of Justice's Antitrust Division, said that "[a]s a result of this international price-fixing and bidrigging conspiracy, automobile manufacturers paid noncompetitive and higher prices for parts in cars sold to U.S. consumers." Ms. Pozen also stated that "[t]his cartel harmed an important industry in our nation's economy, and the Antitrust Division with the Federal Bureau of

Investigation will continue to work together to ensure that these kinds of conspiracies are stopped." The press release also quoted FBI's Special Agent in Charge Andrew G. Arena, who said that "[w]hen companies partner to control and price fix bids or contracts, it undermines the foundation of the United States' economic system," and that "[t]he FBI is committed to aggressively pursuing any company involved in antitrust crimes."

- DENSO Corporation had agreed to plead guilty and to pay a total of \$548 million in criminal fines for their involvement in multiple price-fixing and bid-rigging conspiracies in the sale of automotive parts to automobile manufacturers in the United States. According to the three-count felony charge against Yazaki, it engaged in three separate conspiracies: (i) to rig bids for and fix, stabilize and maintain the prices of automotive wire harnesses and related products; (ii) to rig bids for and fix, stabilize and maintain the prices of instrument panel clusters; and (iii) to fix, stabilize and maintain the prices of fuel senders. According to the two-count felony charge against Defendant DENSO Corporation, it engaged in conspiracies to rig bids for and to fix, stabilize and maintain the prices of electronic control units and heater control panels.
- 142. In the press release announcing the fines against Yazaki Corporation and Defendant DENSO Corporation, Ms. Pozen vowed to continue the investigation into "pernicious cartel conduct that results in higher prices to American consumers . . . ." In the same press release, Special Agent in Charge Andrew G. Arena said that "[t]his criminal activity has a significant impact on the automotive manufacturers in the United States, Canada, Japan and Europe and has been occurring for at least a decade. The conduct had also affected commerce on a global scale in almost every market where automobiles are manufactured and/or sold[.]"

- 143. Ms. Pozen said there is no doubt **consumers** were hurt financially by the automotive wire harness price-fixing conspiracy. She further stated: "By rigging bids on wiring harnesses . . . the three companies inflated what some of their auto manufacturer clients paid, and indirectly, what consumers paid for some cars."
- 144. On March 26, 2012, the DOJ announced that Norihiro Imai, an executive of Defendant DENSO Corporation, agreed to serve one year and one day in a U.S. prison, pay a \$20,000 criminal fine, and plead guilty to a one-count criminal Information charging him with engaging in a conspiracy to rig bids for, and to fix, stabilize, and maintain the prices of heater control panels sold to customers in the United States and elsewhere.
- 145. On April 3, 2012, the DOJ announced that G.S. Electech Inc. had agreed to plead guilty and to pay a \$2.75 million criminal fine for its role in a conspiracy to fix the prices of speed sensor wire assemblies used on antilock brake systems installed in United States automobiles.
- 146. On April 23, 2012, the DOJ announced that Fujikura Ltd. had agreed to plead guilty and to pay a \$220 million criminal fine for its role in a conspiracy to fix prices of automotive wire harnesses and related products installed in United States automobiles.
- 147. On April 26, 2012, the DOJ announced that Makoto Hattori, an executive of Defendant DENSO Corporation, agreed to serve fourteen months in a U.S. prison, pay a \$20,000 criminal fine, and plead guilty to a one-count criminal Information charging him with engaging in a conspiracy to rig bids for, and to fix, stabilize, and maintain the prices of heater control panels sold to a customer in the United States and elsewhere.

- 148. On June 6, 2012, the DOJ announced that Autoliv Inc. had agreed to plead guilty and to pay a \$14.5 criminal fine for its role in a conspiracy to fix prices of seatbelts, airbags and steering wheels installed in United States automobiles to automobile manufacturers.
- 149. On July 30, 2012, the DOJ announced that TRW Deutschland Holding GmbH had agreed to plead guilty and to pay a \$5.1 million criminal fine for its involvement in a conspiracy to fix prices of seatbelts, airbags and steering wheels installed in automobiles sold in the United States.
- 150. On August 28, 2012, the DOJ announced that Nippon Seiki Co. Ltd. had agreed to plead guilty and to pay a \$1 million criminal fine for its role in a conspiracy to fix prices of instrument panel clusters installed in automobiles sold in the United States and elsewhere.
- 151. On October 30, 2012, the DOJ announced that Tokai Rika Co. Ltd. had agreed to plead guilty and to pay a \$17.7 million criminal fine for its role in a conspiracy to fix prices of heater control panels installed in automobiles sold in the United States and elsewhere. Tokai Rika also agreed to plead guilty to a charge of obstruction of justice related to the investigation of the antitrust violation.
- 152. On February 15, 2013, Scott Hammond, the Deputy Assistant Attorney General in the Antitrust Division, discussed the DOJ's ongoing automotive parts investigation in a Thomson Reuters article. He said "[t]he investigation is broader than what we've announced so far . . . . [The investigation] is still very much ongoing, but it already appears to be the biggest criminal antitrust investigation that we've ever encountered. I say the biggest with respect to the impact on U.S. businesses and consumers, and the number of companies and executives that are subject to the investigation." (emphasis added).

- 153. On May 21, 2013, the DOJ announced that Yuji Suzuki, an executive of Defendant DENSO Corporation, agreed to serve sixteen months in a U.S. prison, pay a \$20,000 criminal fine, and plead guilty to a two-count criminal Information for his role in a conspiracy to rig bids for, and to fix, stabilize, and maintain the prices of electronic control units and heater control panels sold in the United States and elsewhere.
- 154. On July 16, 2013, the DOJ announced that Diamond Electric Mfg. Co. Ltd. had agreed to plead guilty and to pay a \$19 million criminal fine for its role in a conspiracy to fix prices of ignition coils installed in automobiles sold in the United States and elsewhere.
- 155. In the press release announcing the fine against Diamond Electric Mfg. Co. Ltd., Robert D. Foley III, Agent in Charge, FBI Detroit Division said "[t]hose who engage in price fixing, bid rigging and other fraudulent schemes harm the automotive industry by driving up costs for vehicle makers and buyers."
- 156. On July 18, 2013, Defendant Panasonic Corporation agreed to plead guilty and to pay a \$45.8 million criminal for its role in a conspiracy to fix prices of various automotive parts including HID Ballasts, switches, and steering angle sensors installed in automobiles sold in the United States and elsewhere.
- 157. On September 24, 2013, the DOJ announced that a grand jury returned an indictment against Shinichi Kotani, an executive of Defendant Panasonic Corporation, for his role in an international conspiracy to fix prices of automotive parts including switches and steering angle sensors sold in the United States and elsewhere.
- 158. On September 26, 2013, nine additional Japanese automotive suppliers agreed to plead guilty to conspiracy charges and pay more than \$740 million in criminal fines for their roles in rigging the prices of more than 30 different products:

- (a) Hitachi Automotive Systems Ltd. agreed to plead guilty and to pay a \$195 million criminal fine for its participation in a conspiracy to rig bids for, and to fix, stabilize and maintain the prices of automotive parts including starter motors, alternators, air flow meters, valve timing control devices, fuel injection systems, electronic throttle bodies, ignition coils, inverters and motor generators sold to automobile manufacturers in the United States and elsewhere;
- (b) Mitsuba Corporation agreed to plead guilty and to pay a \$135 million criminal fine for its participation in a conspiracy to rig bids for, and to fix, stabilize and maintain the prices of certain automotive parts sold to automobile manufactures in the United States and elsewhere. Mitsuba also agreed to plead guilty to one count of obstruction of justice, because of the company's efforts to destroy evidence ordered by a high-level U.S.-based executive after learning of the U.S. investigation of collusion in the automotive parts industry;
- (c) Defendant Mitsubishi Electric Corporation agreed to plead guilty and to pay a \$190 million criminal fine for its participation in a conspiracy to rig bids for, and to fix, stabilize and maintain the prices of certain automotive parts sold to automobile manufacturers in the United States and elsewhere;
- (d) Mitsubishi Heavy Industries Ltd. agreed to plead guilty and to pay a \$14.5 million criminal fine for its participation in a conspiracy to rig bids for, and to fix, stabilize and maintain the prices of compressors and condensers sold to automobile manufacturers in the United States and elsewhere;
- (e) T.RAD Co. Ltd. agreed to plead guilty and to pay a \$13.75 million criminal fine for its participation in a conspiracy to rig bids for, and to fix, stabilize and maintain the prices

of radiators and automatic transmission fluid warmers (ATF warmers) sold to automobile manufacturers in the United States and elsewhere;


- (f) Valeo Japan Co. Ltd. agreed to plead guilty and to pay a \$13.6 million criminal fine for its participation in a conspiracy to allocate the supply of, rig bids for, and to fix, stabilize and maintain the pries of air conditioning systems sold to automobile manufacturers in the United States and elsewhere;
- (g) JTEKT Corporation agreed to plead guilty and to pay a \$103.27 million criminal fine for its participation in a conspiracy to allocate markets, to rig bids for, and to fix, stabilize and maintain the prices of bearings and electric powered steering assemblies sold to automobile manufacturers in the United States and elsewhere;
- (h) NSK Ltd. agreed to plead guilty and to pay a \$68.2 million criminal fine for its participation in a conspiracy to allocate markets, to rig bids for, and to fix, stabilize and maintain the prices of bearings sold to an automobile manufacturer in the United States and elsewhere; and
- (i) Yamashita Rubber Co. Ltd. agreed to plead guilty and to pay a \$11 million criminal fine for its participation in a conspiracy to rig bids for, and to fix, raise and maintain the prices of automotive anti-vibration rubber products sold in the United States and elsewhere to automobile manufacturers.
- 159. On the same day, September 26, 2013, United States Attorney General Eric Holder in the Antitrust Division presented the DOJ's most recent findings in the ongoing automotive parts investigation. He stated "[t]hese international price-fixing conspiracies affected more than \$5 billion in automobile parts sold to U.S. car manufacturers. In total, more than 25 million cars purchased by American consumers were affected by the illegal conduct." Holder

also described how the conspiracies worked: "[c]ompany executives met face to face in the United States and Japan – and talked on the phone – to reach collusive agreements to rig bids, fix prices and allocate the supply of auto parts sold to U.S. car companies. In order to keep their illegal conduct secret, they used code names and met in remote locations. Then they followed up with each other regularly to make sure the collusive agreements were being adhered to."

Attorney General Holder explained that the automotive parts conspiracies "targeted U.S. manufacturing, U.S. businesses and U.S. consumers. As a result of these conspiracies,

Americans paid more for their cars."

160. The diagram below, which was prepared by the DOJ, illustrates the September 26, 2013 guilty pleas and the corresponding automotive parts to which the various manufacturers have admitted price-fixing.



- 161. On October 9, 2013, Takata Corporation announced that it had agreed to pay \$71.3 million to settle antitrust charges brought by the United States federal prosecutors for its role in a conspiracy to price-fix seatbelts.
- 162. On November 26, 2013, the DOJ announced that Toyo Tire & Rubber Co. Ltd. had agreed to plead guilty and to pay a \$120 million criminal fine for its role in two separate conspiracies to fix the prices of automotive components involving anti-vibration rubber and driveshaft parts installed in automobiles sold in the United States and elsewhere.

- 163. On January 16, 2014, the DOJ announced that Defendant Koito Manufacturing Co., Ltd. had agreed to plead guilty and to pay a \$56.6 million criminal fine for its roles in price-fixing conspiracies involving HID Ballasts and automobile lighting fixtures installed in cars sold in the United States and elsewhere.
- 164. On February 3, 2014, the DOJ announced that Aisan Industry Co. Ltd. had agreed to plead guilty and to pay a \$6.86 million criminal fine for its role in a price-fixing conspiracy involving electronic throttle bodies sold to an automobile manufacturer in the United States and elsewhere.
- 165. On February 13, 2014, the DOJ announced that Bridgestone Corp. had agreed to plead guilty and to pay a \$425 million criminal fine for its role in a conspiracy to fix prices of automotive anti-vibration rubber parts installed in automobiles sold in the United States and elsewhere.
- 166. On February 20, 2014, the DOJ announced that Kazuaki Fujitani, a former executive of Defendant DENSO Corporation, agreed to serve one year and one day in a U.S. prison and plead guilty to a one-count criminal Information charging him with obstruction of justice for deleting numerous e-mails and electronic documents upon learning the FBI was executing a search warrant on Defendant DENSO International America, Inc., in connection with the DOJ's investigation into a conspiracy to fix the prices of heater control panels installed in automobiles sold in the United States and elsewhere.
- 167. On April 23, 2014, the DOJ announced that Showa Corp. agreed to plead guilty and to pay a \$19.9 million criminal fine for its role in a conspiracy to fix prices and rig bids for pinion-assist type electric powered steering assemblies installed in cars sold in the United States and elsewhere.

168. To date, twenty-seven companies and thirty-five executives have been charged in the Antitrust Division's ongoing investigation into price fixing and bid rigging in the auto parts industry. Each of the twenty-seven companies has agreed to plead guilty and altogether, they have agreed to pay approximately \$2.3 billion in criminal fines. Twenty-four of the thirty-five executives have been sentenced to serve time in U.S. prisons or have entered into plea agreements.

# **CLASS ACTION ALLEGATIONS**

169. Plaintiffs bring this action on behalf of themselves and as a class action under Rule 23(a) and (b)(2) of the Federal Rules of Civil Procedure, seeking equitable and injunctive relief on behalf of the following class (the "Nationwide Class"):

All persons and entities who, during the Class Period, purchased or leased a new vehicle in the United States not for resale which included one or more HID Ballast(s) as a component part, or indirectly purchased one or more HID Ballast(s) as a replacement part, which were manufactured or sold by a Defendant, any current or former subsidiary of a Defendant or any co-conspirator of the Defendants.

170. Plaintiffs also bring this action on behalf of themselves and as a class action under Rule 23(a) and (b)(3) of the Federal Rules of Civil Procedure seeking damages pursuant to state antitrust, unfair competition, and consumer protection laws on behalf of the following class (the "Damages Class"):

All persons and entities who, during the Class Period, purchased or leased a new vehicle in the Indirect Purchaser States<sup>1</sup> not for resale which included one or more HID Ballast(s) as a component part, or indirectly purchased one or more HID Ballast(s) as a replacement part, which were manufactured or sold by a Defendant, any current

or former subsidiary of a Defendant or any co-conspirator of the Defendants.

- 171. The Nationwide Class and the Damages Class are referred to herein as the "Classes." Excluded from the Classes are the Defendants, their parent companies, subsidiaries and affiliates, any co-conspirators, federal governmental entities and instrumentalities of the federal government, states and their subdivisions, agencies and instrumentalities, and persons who purchased HID Ballasts directly or for resale.
- 172. While Plaintiffs do not know the exact number of the members of the Classes, Plaintiffs believe there are (at least) thousands of members in each Class.
- 173. Common questions of law and fact exist as to all members of the Classes. This is particularly true given the nature of the Defendants' and their co-conspirators' conspiracy, which was generally applicable to all the members of both Classes, thereby making appropriate relief with respect to the Classes as a whole. Such questions of law and fact common to the Classes include, but are not limited to:
- (a) Whether the Defendants and their co-conspirators engaged in a combination and conspiracy among themselves to fix, raise, maintain or stabilize the prices of HID Ballasts sold in the United States;
  - (b) The identity of the participants of the alleged conspiracy;
- (c) The duration of the alleged conspiracy and the acts carried out by the Defendants and their co-conspirators in furtherance of the conspiracy;
- (d) Whether the alleged conspiracy violated the Sherman Act, as alleged in the First Claim for Relief:
- (e) Whether the alleged conspiracy violated state antitrust and unfair competition law, and/or state consumer protection law, as alleged in the Second and Third Claims for Relief;

- (f) Whether the conduct of the Defendants and their co-conspirators, as alleged in this Complaint, caused injury to the business or property of Plaintiffs and the members of the Classes;
- (g) The effect of the alleged conspiracy on the prices of HID Ballasts sold in theUnited States during the Class Period;
- (h) Whether Plaintiffs and the members of the Classes had any reason to know or suspect the conspiracy, or any means to discover the conspiracy;
- (i) Whether the Defendants and their co-conspirators fraudulently concealed the conspiracy's existence from Plaintiffs and the members of the Classes;
- (j) The appropriate injunctive and related equitable relief for the Nationwide
   Class; and
  - (k) The appropriate class-wide measure of damages for the Damages Class.
  - 174. Plaintiffs' claims are typical of the claims of the members of the Classes, and Plaintiffs will fairly and adequately protect the interests of the Classes. Plaintiffs and all members of the Classes are similarly affected by the Defendants' wrongful conduct in that they paid artificially inflated prices for HID Ballasts purchased indirectly from the Defendants and/or their co-conspirators.
  - 175. Plaintiffs' claims arise out of the same common course of conduct giving rise to the claims of the other members of the Classes. Plaintiffs' interests are coincident with, and not antagonistic to, those of the other members of the Classes. Plaintiffs are represented by counsel who are competent and experienced in the prosecution of antitrust and class action litigation.

- 176. The questions of law and fact common to the members of the Classes predominate over any questions affecting only individual members, including legal and factual issues relating to liability and damages.
- 177. Class action treatment is a superior method for the fair and efficient adjudication of the controversy, in that, among other things, such treatment will permit a large number of similarly situated persons to prosecute their common claims in a single forum simultaneously, efficiently and without the unnecessary duplication of evidence, effort and expense that numerous individual actions would engender. The benefits of proceeding through the class mechanism, including providing injured persons or entities with a method for obtaining redress for claims that might not be practicable to pursue individually, substantially outweigh any difficulties that may arise in the management of this class action.
- 178. The prosecution of separate actions by individual members of the Classes would create a risk of inconsistent or varying adjudications, establishing incompatible standards of conduct for the Defendants.

# PLAINTIFFS AND THE CLASSES SUFFERED ANTITRUST INJURY

- 179. The Defendants' price-fixing conspiracy had the following effects, among others:
- (a) Price competition has been restrained or eliminated with respect to HID Ballasts:
- (b) The prices of HID Ballasts have been fixed, raised, maintained, or stabilized at artificially inflated levels;
- (c) Indirect purchasers of HID Ballasts have been deprived of free and open competition; and
  - (d) Indirect purchasers of HID Ballasts paid artificially inflated prices.

- 180. During the Class Period, Plaintiffs and the members of the Classes paid supracompetitive prices for HID Ballasts. These inflated prices have been passed on to them by OEMs and dealers.
- 181. The markets for HID Ballasts and vehicles are inextricably linked and intertwined because the market for HID Ballasts exists to serve the vehicle market. Without the vehicles, HID Ballasts have little to no value because they have no independent utility. Indeed, the demand for vehicles creates the demand for HID Ballasts. As stated in the 2010 Annual Report of Lear Corporation, an automobile parts supplier: "Our sales are driven by the number of vehicles produced by the automotive manufacturers, which is ultimately dependent on consumer fleet demand for automotive vehicles."
- 182. HID Ballasts are identifiable, discrete physical products that remain essentially unchanged when incorporated into a vehicle. As a result, HID Ballasts follow a traceable physical chain of distribution from the Defendants to Plaintiffs and the members of the Classes, and any costs attributable to HID Ballasts can be traced through the chain of distribution to Plaintiffs and the members of the Classes.
- 183. Just as HID Ballasts can be physically traced through the supply chain, so can their price be traced to show that changes in the prices paid by direct purchasers of HID Ballasts affect prices paid by indirect purchasers of new motor vehicles containing HID Ballasts and HID Ballasts purchased for repair purposes.
- 184. While even a monopolist would increase its prices when the cost of its inputs increased, the economic necessity of passing through cost changes increases with the degree of competition a firm faces. The OEM and dealer markets for new motor vehicles are subject to vigorous price competition. The OEMs and dealers have thin net margins, and are therefore at

the mercy of their component costs, such that increases in the price of components such as HID Ballasts lead to corresponding increases in prices for new motor vehicles and replacement parts at the OEM and dealer levels. When downstream distribution markets are highly competitive, as they are in the case of new motor vehicles containing HID Ballasts as components, overcharges are passed through to ultimate consumers, such as the indirect-purchaser Plaintiffs and class members.

- 185. Hence the inflated prices of HID Ballasts both in new motor vehicles and those purchased for repair resulting from the Defendants' and their co-conspirators' bid-rigging and price-fixing conspiracy have been passed on to Plaintiffs and other class members by OEMs and dealers.
- 186. The economic and legal literature has recognized that unlawful overcharges in a component normally result in higher prices for products containing that price-fixed component. Two antitrust scholars Professors Robert G. Harris (Professor Emeritus and former Chair of the Business and Public Policy Group at the Haas School of Business at the University of California at Berkeley) and the late Lawrence A. Sullivan (Professor of Law Emeritus at Southwestern Law School and author of the Handbook of the Law of Antitrust) have observed that "in a multiple-level chain of distribution, passing on monopoly overcharges is not the exception: it is the rule."
- 187. As Professor Jeffrey K. MacKie-Mason (Arthur W. Burks Professor for Information and Computer Science and Professor of Economics and Public Certification), an expert who presented evidence in a number of indirect purchaser cases involving Microsoft

Corporation, said (in a passage quoted in the judicial decision in that case granting class certification):

As is well known in economic theory and practice, at least some of the overcharge will be passed on by distributors to end consumers. When the distribution markets are highly competitive, as they are here, all or nearly the entire overcharge will be passed on through to ultimate consumers...Both of Microsoft's experts also agree upon the economic phenomenon of cost pass through, and how it works in competitive markets. This general phenomenon of cost pass through is well established in antitrust laws and economics as well.<sup>3</sup>

conspirators was to raise, fix, rig or stabilize the prices of HID Ballasts and, as a direct and foreseeable result, the price of new motor vehicles containing HID Ballasts and the prices of HID Ballasts purchased for repair purposes. Economists have developed techniques to isolate and understand the relationship between one "explanatory" variable and a "dependent" variable in those cases when changes in the dependent variable are explained by changes in a multitude of variables, even when all such variables may be changing simultaneously. That analysis - called regression analysis - is commonly used in the real world and in litigation to determine the impact of a price increase on one cost in a product (or service) that is an assemblage of costs. Thus, it is possible to isolate and identify only the impact of an increase in the prices of HID Ballasts on prices for new motor vehicles even though such products contain a number of other components whose prices may be changing over time. A regression model can explain how variation in the prices of HID Ballasts affects changes in the price of new motor vehicles. In such models, the

prices of HID Ballasts would be treated as independent or explanatory variables. The model can isolate how changes in the prices of HID Ballasts impact the price of new motor vehicles containing HID Ballasts while controlling for the impact of other price-determining factors.

- 189. The precise amount of the overcharge impacting the prices of new motor vehicles containing HID Ballasts can be measured and quantified. Commonly used and well-accepted economic models can be used to measure both the extent and the amount of the supracompetitive charge passed through the chain of distribution. Thus, the economic harm to Plaintiffs and class members can be quantified.
- 190. In addition to the regression analysis discussed above demonstrating impact on consumers, the Department of Justice's Antitrust Division, which has been investigating anticompetitive conduct in the automotive parts industry for some time, has concluded that there is "no doubt" that consumers were hurt financially. Sharis A. Pozen, then Acting Assistant Attorney General in charge of the Department of Justice's Antitrust Division said there is no doubt consumers were hurt financially by the automotive wire harness price-fixing conspiracy. "By rigging bids . . . [automotive parts manufacturers engaged in a price-fixing conspiracy] inflated what some of their auto manufacturing clients paid, and indirectly, what consumers paid for some cars," Ms. Pozen said. She also explained that "[a]s a result of this international price-fixing and bid-rigging conspiracy, automobile manufacturers paid noncompetitive and higher prices for parts in cars sold to U.S. consumers." Ms. Pozen also stated that "[t]his cartel harmed an important industry in our nation's economy, and the Antitrust Division with the Federal Bureau of Investigation will continue to work together to ensure that these kinds of conspiracies are stopped." In a separate press statement, Ms. Pozen vowed to

continue the investigation into "pernicious cartel conduct that results in higher prices to American consumers . . . ."

- 191. On February 15, 2013, Scott Hammond, the Deputy Assistant Attorney General in the Antitrust Division, discussed the DOJ's ongoing automotive parts investigation in a Thomson Reuters article. He said "[t]he investigation is broader than what we've announced so far . . . . [The investigation] is still very much ongoing, but it already appears to be the biggest criminal antitrust investigation that we've ever encountered. I say the biggest with respect to the impact on U.S. businesses and consumers, and the number of companies and executives that are subject to the investigation." (emphasis added).

Attorney General Holder explained that the automotive parts conspiracies "targeted U.S. manufacturing, U.S. businesses and U.S. consumers. As a result of these conspiracies, Americans paid more for their cars."

- 193. On May 25, 2014, news sources reported that Brent Snyder, a deputy assistant attorney general in the Antitrust Division, said with respect to the automotive parts conspiracies, "[i]t's a very, very safe assumption that U.S. consumers paid more, and sometimes significantly more, for their automobiles as a result of this conspiracy."
- 194. By reason of the violations of the antitrust law alleged herein, Plaintiffs and the members of the Classes have sustained injury to their businesses or property, having paid higher prices for HID Ballasts than they would have paid in the absence of the Defendants' and their co-conspirators' illegal contract, combination, or conspiracy, and, as a result, have suffered damages in an amount presently undetermined. This is an antitrust injury of the type that the antitrust laws were meant to punish and prevent.

# PLAINTIFFS' CLAIMS ARE NOT BARRED BY THE STATUTE OF LIMITATIONS

- A. The Statute of Limitations Did Not Begin to Run Because Plaintiffs Did Not And Could Not Discover Their Claims
- 195. Plaintiffs repeat and re-allege the allegations set forth above.
- 196. Plaintiffs and the members of the Classes had no knowledge of the combination or conspiracy alleged herein, or of facts sufficient to place them on inquiry notice of the claims set forth herein, until (at the earliest) July 18, 2013, the date that the DOJ publicly announced Defendant Panasonic Corporation's anticipated guilty plea.<sup>4</sup>

Stanley Electric Co., Ltd.'s anticipated guilty plea. No information in the public domain was available to the Plaintiffs and the members of the Classes prior to November 27, 2013, the date that the DOJ publicly announced Defendant Stanley Electric Co., Ltd.'s anticipated guilty plea, that revealed sufficient information to suggest that Stanley was involved in a conspiracy to price

- 197. Plaintiffs and the members of the Classes are purchasers who purchased or leased automobiles or purchased HID Ballasts to replace or repair damaged or defective HID Ballasts in their automobiles. They had no direct contact or interaction with the Defendants in this case and had no means from which they could have discovered the combination and conspiracy described in this Complaint before July 18, 2013, the date that the DOJ publicly announced Defendant Panasonic Corporation's anticipated guilty plea.
- 198. No information in the public domain was available to the Plaintiffs and the members of the Classes prior to July 18, 2013, the date that the DOJ publicly announced Defendant Panasonic Corporation's anticipated guilty plea, that revealed sufficient information to suggest that the Defendants were involved in a criminal conspiracy to price-fix and rig bids for HID Ballasts. Plaintiffs and the members of the Classes had no means of obtaining any facts or information concerning any aspect of the Defendants' dealings with OEMs or other direct purchasers, much less the fact that they and their co-conspirators had engaged in the combination and conspiracy alleged herein.

fix HID Ballasts. Therefore, with respect to Defendant Stanley, the statute of limitations did not begin to run because Plaintiffs did not and could not discover their claims, or in the alternative, because fraudulent concealment tolled the statute of limitations, until November 27, 2013.

With respect to Defendant Koito, Plaintiffs had no knowledge of the combination or conspiracy alleged herein, or of facts sufficient to place them on inquiry notice of the claims set forth herein, until (at the earliest), January 16, 2014, the date the DOJ publicly announced Defendant Koito Manufacturing Co., Ltd.'s anticipated guilty plea. No information in the public domain was available to the Plaintiffs and the members of the Classes prior to January 16, 2014, the date the DOJ publicly announced Defendant Koito Manufacturing Co., Ltd.'s anticipated guilty plea, that revealed sufficient information to suggest that Koito was involved in a conspiracy to price fix HID Ballasts. Therefore, with respect to Defendant Koito, the statute of limitations did not begin to run because Plaintiffs did not and could not discover their claims, or in the alternative, because fraudulent concealment tolled the statute of limitations, until January 16, 2014.

199. For these reasons, the statute of limitations as to Plaintiffs' and the Classes' claims did not begin to run, and has been tolled with respect to the claims that Plaintiffs and the members of the Classes have alleged in this Complaint.

# **B.** Fraudulent Concealment Tolled the Statute of Limitations

- 200. In the alternative, application of the doctrine of fraudulent concealment tolled the statute of limitations on the claims asserted herein by Plaintiffs and the Classes. Plaintiffs and the members of the Classes did not discover, and could not discover through the exercise of reasonable diligence, the existence of the conspiracy alleged herein until July 18, 2013, the date that the DOJ publicly announced Defendant Panasonic Corporation's anticipated guilty plea.<sup>5</sup>
- 201. Before that time, Plaintiffs and members of the Classes were unaware of the Defendants' unlawful conduct, and did not know before then that they were paying supracompetitive prices for HID Ballasts throughout the United States during the Class Period. No information, actual or constructive, was ever made available to Plaintiffs and the members of the Classes that even hinted to Plaintiffs that they were being injured by the Defendants' unlawful conduct.
- 202. The affirmative acts of the Defendants alleged herein, including acts in furtherance of the conspiracy, were wrongfully concealed and carried out in a manner that precluded detection.
- 203. Specifically, as Attorney General Holder explained in connection with the DOJ's globally coordinated investigation into price-fixing in the automotive parts industry, "[i]n order to keep their illegal conduct secret, [Defendants] used code names and met in remote locations."

- 204. As stated in the Information filed against Defendants Panasonic Corporation,
  Stanley Electric Co., Ltd., and Koito Manufacturing Co., Ltd., respectively, Panasonic
  Corporation, Stanley Electric Co., Ltd., and Koito Manufacturing Co., Ltd. all employed
  "measures to keep their conduct secret, including using code names and choosing meeting places
  and times to avoid detection." Also, as stated in the Information filed against Mitsubishi Electric
  Corporation, the Defendants and their co-conspirators employed "measures to keep their conduct
  secret, including, but not limited to, using code names and meeting at remote locations."
- 205. Additionally, Mitsubishi Electric Corporation admitted to destroying and/or altering documents in an effort to cover up its unlawful activity.
- 206. According to Mitsubishi Electric Corporation's plea agreement, in February 2010, Mitsubishi Electric Corporation's employees became aware of the criminal investigation into the price-fixing of automotive parts, including Alternators, when one of its co-conspirators was searched by law enforcement officers in the United States. Upon learning of the searches, Mitsubishi Electric Corporation's employees took steps to destroy evidence of their criminal activity, which was approved by their senior managers in Japan. This evidence included files and paper documents in the United States and Japan.
- 207. By its very nature, the Defendants' and their co-conspirators' anticompetitive conspiracy was inherently self-concealing. HID Ballasts are not exempt from antitrust regulation, and thus, before July 18, 2013, Plaintiffs reasonably considered HID Ballasts industry to be a competitive industry. Accordingly, a reasonable person under the circumstances would not have been alerted to begin to investigate the legitimacy of the Defendants' HID Ballast prices prior to July 18, 2013, the date that the DOJ publically announced Panasonic Corporation's anticipated guilty plea.

- 208. Plaintiffs and the members of the Classes could not have discovered the alleged contract, conspiracy or combination at an earlier date by the exercise of reasonable diligence because of the deceptive practices and techniques of secrecy employed by the Defendants and their co-conspirators to avoid detection of, and fraudulently conceal, their contract, combination, or conspiracy.
- 209. Because the alleged conspiracy was both self-concealing and affirmatively concealed by the Defendants and their co-conspirators, Plaintiffs and members of the Classes had no knowledge of the alleged conspiracy, or of any facts or information that would have caused a reasonably diligent person to investigate whether a conspiracy existed, until July 18, 2013, the date that the DOJ publicly announced Defendant Panasonic Corporation's anticipated guilty plea.
- 210. For these reasons, the statute of limitations applicable to Plaintiffs' and the Classes' claims with respect to the HID Ballasts conspiracy was tolled and did not begin to run until July 18, 2013.

# FIRST CLAIM FOR RELIEF Violation of Section 1 of the Sherman Act (on behalf of Plaintiffs and the Nationwide Class)

- 211. Plaintiffs incorporate by reference the allegations in the preceding paragraphs.
- 212. The Defendants and unnamed co-conspirators entered into and engaged in a contract, combination, or conspiracy in unreasonable restraint of trade in violation of Section 1 of the Sherman Act (15 U.S.C. § 1).
- 213. The acts done by the Defendants as part of, and in furtherance of, their and their co-conspirators' contract, combination, or conspiracy were authorized, ordered, or done by their officers, agents, employees, or representatives while actively engaged in the management of their affairs.

- 214. At least as early as July 1998, and continuing until at least the filing of this Complaint, the exact dates being unknown to Plaintiffs, the Defendants and their co-conspirators entered into a continuing agreement, understanding and conspiracy in restraint of trade to artificially fix, raise, stabilize, and control prices for HID Ballasts, thereby creating anticompetitive effects.
- 215. The anticompetitive acts were intentionally directed at the United States market for HID Ballasts and had a substantial and foreseeable effect on interstate commerce by raising and fixing prices for HID Ballasts throughout the United States.
- 216. The conspiratorial acts and combinations have caused unreasonable restraints in the market for HID Ballasts.
- 217. As a result of the Defendants' unlawful conduct, Plaintiffs and other similarly situated indirect purchasers in the Nationwide Class who purchased HID Ballasts have been harmed by being forced to pay inflated, supracompetitive prices for HID Ballasts.
- 218. In formulating and carrying out the alleged agreement, understanding and conspiracy, the Defendants and their co-conspirators did those things that they combined and conspired to do, including but not limited to the acts, practices and course of conduct set forth herein.
- 219. The Defendants' and their co-conspirators' conspiracy had the following effects, among others:
- (a) Price competition in the market for HID Ballasts has been restrained, suppressed, and/or eliminated in the United States;

- (b) Prices for HID Ballasts sold by the Defendants and their co-conspirators have been fixed, raised, maintained, and stabilized at artificially high, non-competitive levels throughout the United States; and
- (c) Plaintiffs and members of the Nationwide Class who purchased HID Ballasts indirectly from the Defendants and their co-conspirators have been deprived of the benefits of free and open competition.
- 220. Plaintiffs and members of the Nationwide Class have been injured and will continue to be injured in their business and property by paying more for HID Ballasts purchased indirectly from the Defendants and their co-conspirators than they would have paid and will pay in the absence of the conspiracy.
- 221. The alleged contract, combination, or conspiracy is a *per se* violation of the federal antitrust laws.
- 222. Plaintiffs and members of the Nationwide Class are entitled to an injunction against the Defendants, preventing and restraining the violations alleged herein.

# SECOND CLAIM FOR RELIEF

# Violation of State Antitrust Statutes (on behalf of Plaintiffs and the Damages Class)

- 223. Plaintiffs incorporate by reference the allegations in the preceding paragraphs.
- 224. From as early as July 1998 until at least the filing of this Complaint, the Defendants and their co-conspirators engaged in a continuing contract, combination or conspiracy with respect to the sale of HID Ballasts in unreasonable restraint of trade and commerce and in violation of the various state antitrust and other statutes set forth below.
- 225. The contract, combination, or conspiracy consisted of an agreement among the Defendants and their co-conspirators to fix, raise, inflate, stabilize, and/or maintain at artificially

supracompetitive prices for HID Ballasts and to allocate customers for HID Ballasts in the United States.

- 226. In formulating and effectuating this conspiracy, the Defendants and their coconspirators performed acts in furtherance of the combination and conspiracy, including:
- (a) participating in meetings and conversations among themselves in the United States and elsewhere during which they agreed to prices of HID Ballasts at certain levels, and otherwise to fix, increase, inflate, maintain, or stabilize effective prices paid by Plaintiffs and members of the Damages Class with respect to HID Ballasts sold in the United States;
- (b) allocating customers and markets for HID Ballasts in the United States in furtherance of their agreements; and
- (c) participating in meetings and conversations among themselves in the United States and elsewhere to implement, adhere to, and police the unlawful agreements they reached.
- 227. The Defendants and their co-conspirators engaged in the actions described above for the purpose of carrying out their unlawful agreements to fix, maintain, increase, or stabilize prices and to allocate customers with respect to HID Ballasts.
- 228. The Defendants' anticompetitive acts described above were knowing and willful and constitute violations or flagrant violations of the following state antitrust statutes.
- 229. The Defendants have entered into an unlawful agreement in restraint of trade in violation of the Arizona Revised Statutes, §§ 44-1401, *et seq*.
- (a) The Defendants' and their co-conspirators' combinations or conspiracies had the following effects: (1) HID Ballast price competition was restrained, suppressed, and eliminated throughout Arizona; (2) HID Ballast prices were raised, fixed, maintained and stabilized at artificially high levels throughout Arizona; (3) Plaintiffs and members of the

Damages Class were deprived of free and open competition; and (4) Plaintiffs and members of the Damages Class paid supracompetitive, artificially inflated prices for HID Ballasts.

- (b) During the Class Period, the Defendants' illegal conduct substantially affected Arizona commerce.
- (c) As a direct and proximate result of the Defendants' unlawful conduct,

  Plaintiffs and members of the Damages Class have been injured in their business and property

  and are threatened with further injury.
- (d) By reason of the foregoing, the Defendants entered into agreements in restraint of trade in violation of Ariz. Rev. Stat. §§ 44-1401, *et seq.* Accordingly, Plaintiffs and members of the Damages Class seek all forms of relief available under Ariz. Rev. Stat. §§ 44-1401, *et seq.*
- 230. The Defendants have entered into an unlawful agreement in restraint of trade in violation of the California Business and Professions Code, §§ 16700, et seq.
- (a) During the Class Period, the Defendants and their co-conspirators entered into and engaged in a continuing unlawful trust in restraint of the trade and commerce described above in violation of Section 16720, California Business and Professions Code. The Defendants have acted in violation of Section 16720 to fix, raise, stabilize, and maintain prices of, and allocate markets for, HID Ballasts at supracompetitive levels.
- (b) The aforesaid violations of Section 16720, California Business and Professions Code, consisted, without limitation, of a continuing unlawful trust and concert of action among the Defendants and their co-conspirators, the substantial terms of which were to fix, raise, maintain, and stabilize the prices of, and to allocate markets for, HID Ballasts.

- (c) For the purpose of forming and effectuating the unlawful trust, the

  Defendants and their co-conspirators have done those things which they combined and conspired
  to do, including but in no way limited to the acts, practices and course of conduct set forth above
  and the following: (1) Fixing, raising, stabilizing, and pegging the prices of HID Ballasts; and
  (2) Allocating among themselves the production of HID Ballasts.
- (d) The combination and conspiracy alleged herein has had, inter alia, the following effects: (1) Price competition in the sale of HID Ballasts has been restrained, suppressed, and/or eliminated in the State of California; (2) Prices for HID Ballasts sold by the Defendants and their co-conspirators have been fixed, raised, stabilized, and pegged at artificially high, non-competitive levels in the State of California and throughout the United States; and (3) those who purchased HID Ballasts directly or indirectly from the Defendants and their co-conspirators have been deprived of the benefit of free and open competition.
- (e) As a direct and proximate result of the Defendants' unlawful conduct, Plaintiffs and members of the Damages Class have been injured in their business and property in that they paid more for HID Ballasts than they otherwise would have paid in the absence of the Defendants' unlawful conduct. As a result of the Defendants' violation of Section 16720 of the California Business and Professions Code, Plaintiffs and members of the Damages Class seek treble damages and their cost of suit, including a reasonable attorney's fee, pursuant to Section 16750(a) of the California Business and Professions Code.
- 231. The Defendants have entered into an unlawful agreement in restraint of trade in violation of the District of Columbia Code Annotated §§ 28-4501, *et seq.*
- (a) The Defendants' and their co-conspirators' combinations or conspiracies had the following effects: (1) HID Ballast price competition was restrained, suppressed, and

Accordingly, Plaintiffs and the members of the Damages Class in each of the above jurisdictions seek damages (including statutory damages where applicable), to be trebled or otherwise increased as permitted by a particular jurisdiction's antitrust law, and costs of suit, including reasonable attorneys' fees, to the extent permitted by the above state laws.

# THIRD CLAIM FOR RELIEF

Violation of State Consumer Protection Statutes (on behalf of Plaintiffs and the Damages Class)

- (e) Defendants have or will be mailed or delivered a demand letter in accordance with G.L. c. 93A, § 9, or, upon information and belief, such receipt of a demand letter was unnecessary due to the Defendants not maintaining a place of business within the Commonwealth of Massachusetts or not keeping assets within the Commonwealth.
- (f) By reason of the foregoing, the Defendants engaged in unfair competition and unfair or deceptive acts and practices, in violation of G.L. c. 93A, § 2. The Defendants' and their co-conspirators' violations of Chapter 93A were knowing or willful, entitling Plaintiffs and members of the Damages Class to multiple damages.
- 263. The Defendants have engaged in unfair competition or unfair, unconscionable, or deceptive acts or practices in violation of the Missouri Merchandising Practices Act, Mo. Rev. Stat. § 407.010, *et seq.*
- (a) Plaintiffs and the Damages Class purchased HID Ballasts for personal, family, or household purposes.
- (b) The Defendants engaged in the conduct described herein in connection with the sale of HID Ballasts in trade or commerce in a market that includes Missouri.
- (c) The Defendants and their co-conspirators agreed to, and did in fact, affect, fix, control, and/or maintain, at artificial and non-competitive levels, the prices at which HID Ballasts were sold, distributed, or obtained in Missouri, which conduct constituted unfair

practices in that it was unlawful under federal and state law, violated public policy, was unethical, oppressive and unscrupulous, and caused substantial injury to Plaintiffs and members of the Damages Class.

- (d) The Defendants concealed, suppressed, and omitted to disclose material facts to Plaintiffs and members of the Damages Class concerning their unlawful activities and artificially inflated prices for HID Ballasts. The concealed, suppressed, and omitted facts would have been important to Plaintiffs and members of the Damages Class as they related to the cost of HID Ballasts they purchased.

- (h) Accordingly, Plaintiffs and members of the Damages Class seek all relief available under Missouri's Merchandising Practices Act, specifically Mo. Rev. Stat. § 407.020, which prohibits "the act, use or employment by any person of any deception, fraud, false pretense, false promise, misrepresentation, unfair practice or the concealment, suppression, or

omission of any material fact in connection with the sale or advertisement of any merchandise in trade or commerce...," as further interpreted by the Missouri Code of State Regulations, 15 CSR 60-7.010, *et seq.*, 15 CSR 60-8.010, *et seq.*, and 15 CSR 60-9.010, *et seq.*, and Mo. Rev. Stat. § 407.025, which provides for the relief sought in this count.

- (b) During the Class Period, the Defendants' illegal conduct substantially affected Montana commerce and consumers.
- (c) As a direct and proximate result of the Defendants' unlawful conduct,

  Plaintiffs and members of the Damages Class have been injured and are threatened with further injury.

- (a) The Defendants and their co-conspirators agreed to, and did in fact, act in restraint of trade or commerce by affecting, fixing, controlling and/or maintaining at non-competitive and artificially inflated levels, the prices at which HID Ballasts were sold, distributed or obtained in New Mexico and took efforts to conceal their agreements from Plaintiffs and members of the Damages Class.
- (b) The aforementioned conduct on the part of the Defendants constituted "unconscionable trade practices," in violation of N.M.S.A. Stat. § 57-12-3, in that such conduct, *inter alia*, resulted in a gross disparity between the value received by Plaintiffs and the members of the Damages Class and the prices paid by them for HID Ballasts as set forth in N.M.S.A., § 57-12-2E.

- (a) The Defendants and their co-conspirators agreed to, and did in fact, act in restraint of trade or commerce by affecting, fixing, controlling and/or maintaining, at artificial and non-competitive levels, the prices at which HID Ballasts were sold, distributed or obtained in North Carolina and took efforts to conceal their agreements from Plaintiffs and members of the Damages Class.
- (b) The conduct of the Defendants described herein constitutes consumeroriented deceptive acts or practices within the meaning of North Carolina law, which resulted in
  consumer injury and broad adverse impact on the public at large, and harmed the public interest

The Defendants have engaged in unfair competition or unfair or deceptive acts or practices in violation of North Carolina Gen. Stat. § 75-1.1, *et seq.*, and, accordingly, Plaintiffs and members of the Damages Class seek all relief available under that statute.
- 268. The Defendants have engaged in unfair competition or unfair, unconscionable, or deceptive acts or practices in violation of the Rhode Island Unfair Trade Practice and Consumer Protection Act, R.I. Gen. Laws §§ 6-13.1-1, *et seq*.
- (a) Plaintiffs and members of the Damages Class purchased HID Ballasts for personal, family, or household purposes.
- (b) The Defendants and their co-conspirators agreed to, and did in fact, act in restraint of trade or commerce in a market that includes Rhode Island, by affecting, fixing, controlling, and/or maintaining, at artificial and non-competitive levels, the prices at which HID Ballasts were sold, distributed, or obtained in Rhode Island.
- (c) The Defendants deliberately failed to disclose material facts to Plaintiffs and members of the Damages Class concerning their unlawful activities and artificially inflated prices for HID Ballasts. The Defendants owed a duty to disclose such facts, and considering the relative lack of sophistication of the average, non-business purchaser, they breached that duty by

their silence. The Defendants misrepresented to all purchasers during the Class Period that their HID Ballast prices were competitive and fair.

- (d) The Defendants' unlawful conduct had the following effects: (1) HID Ballast price competition was restrained, suppressed, and eliminated throughout Rhode Island; (2) HID Ballast prices were raised, fixed, maintained, and stabilized at artificially high levels throughout Rhode Island; (3) Plaintiffs and members of the Damages Class were deprived of free and open competition; and (4) Plaintiffs and members of the Damages Class paid supracompetitive, artificially inflated prices for HID Ballasts.
- (e) As a direct and proximate result of the Defendants' violations of law,

  Plaintiffs and members of the Damages Class suffered an ascertainable loss of money or property

  as a result of the Defendants' use or employment of unconscionable and deceptive commercial

  practices as set forth above. That loss was caused by the Defendants' willful and deceptive

  conduct, as described herein.
- of HID Ballasts, likely misled all purchasers acting reasonably under the circumstances to believe that they were purchasing HID Ballasts at prices born by a free and fair market. The Defendants' omissions constitute information important to Plaintiffs and members of the Damages Class as they related to the cost of HID Ballasts they purchased.
- (g) The Defendants have engaged in unfair competition or unfair or deceptive acts or practices in violation of Rhode Island Gen. Laws. § 6-13.1-1, *et seq.*, and, accordingly, Plaintiffs and members of the Damages Class seek all relief available under that statute.

- 269. The Defendants have engaged in unfair competition or unfair, unconscionable, or deceptive acts or practices in violation of South Carolina Unfair Trade Practices Act, S.C. Code Ann. §§ 39-5-10, *et seq*.
- (a) The Defendants' combinations or conspiracies had the following effects:

  (1) HID Ballast price competition was restrained, suppressed, and eliminated throughout South Carolina; (2) HID Ballast prices were raised, fixed, maintained, and stabilized at artificially high levels throughout South Carolina; (3) Plaintiffs and members of the Damages Class were deprived of free and open competition; and (4) Plaintiffs and members of the Damages Class paid supracompetitive, artificially inflated prices for HID Ballasts.
- (b) During the Class Period, the Defendants' illegal conduct had a substantial effect on South Carolina commerce.
- (c) As a direct and proximate result of the Defendants' unlawful conduct,

  Plaintiffs and members of the Damages Class have been injured in their business and property

  and are threatened with further injury.
- (d) The Defendants have engaged in unfair competition or unfair or deceptive acts or practices in violation of S.C. Code Ann. §§ 39-5-10, *et seq.*, and, accordingly, Plaintiffs and the members of the Damages Class seek all relief available under that statute.
- 270. The Defendants have engaged in unfair competition or unfair, unconscionable, or deceptive acts or practices in violation of 9 Vermont § 2451, *et seq*.
- (a) The Defendants and their co-conspirators agreed to, and did in fact, act in restraint of trade or commerce in a market that includes Vermont by affecting, fixing, controlling, and/or maintaining, at artificial and non-competitive levels, the prices at which HID Ballasts were sold, distributed, or obtained in Vermont.

- (b) The Defendants deliberately failed to disclose material facts to Plaintiffs and members of the Damages Class concerning their unlawful activities and artificially inflated prices for HID Ballasts. The Defendants owed a duty to disclose such facts, and considering the relative lack of sophistication of the average, non-business purchaser, the Defendants breached that duty by their silence. The Defendants misrepresented to all purchasers during the Class Period that their HID Ballast prices were competitive and fair.
- (c) The Defendants' unlawful conduct had the following effects: (1) HID Ballast price competition was restrained, suppressed, and eliminated throughout Vermont; (2) HID Ballast prices were raised, fixed, maintained, and stabilized at artificially high levels throughout Vermont; (3) Plaintiffs and members of the Damages Class were deprived of free and open competition; and (4) Plaintiffs and members of the Damages Class paid supracompetitive, artificially inflated prices for HID Ballasts.
- (d) As a direct and proximate result of the Defendants' violations of law,

  Plaintiffs and members of the Damages Class suffered an ascertainable loss of money or property

  as a result of the Defendants' use or employment of unconscionable and deceptive commercial

  practices as set forth above. That loss was caused by the Defendants' willful and deceptive

  conduct, as described herein.
- (e) The Defendants' deception, including their omissions concerning the prices of HID Ballasts, likely misled all purchasers acting reasonably under the circumstances to believe that they were purchasing HID Ballasts at prices born by a free and fair market. The Defendants' misleading conduct and unconscionable activities constitutes unfair competition or unfair or deceptive acts or practices in violation of 9 Vermont § 2451, *et seq.*, and, accordingly, Plaintiffs and members of the Damages Class seek all relief available under that statute.

#### PRAYER FOR RELIEF

Accordingly, Plaintiffs respectfully request that:

- A. The Court determine that this action may be maintained as a class action under Rule 23(a), (b)(2) and (b)(3) of the Federal Rules of Civil Procedure, and direct that reasonable notice of this action, as provided by Rule 23(c)(2) of the Federal Rules of Civil Procedure, be given to each and every member of the Classes;
- B. That the unlawful conduct, contract, conspiracy, or combination alleged herein be adjudged and decreed:
- (a) An unreasonable restraint of trade or commerce in violation of Section 1 of the Sherman Act;
  - (b) A per se violation of Section 1 of the Sherman Act; and
- (c) An unlawful combination, trust, agreement, understanding and/or concert of action in violation of the state antitrust and unfair competition and consumer protection laws as set forth herein.
- C. Plaintiffs and the members of the Damages Class recover damages, to the maximum extent allowed under such laws, and that a joint and several judgment in favor of Plaintiffs and the members of the Damages Class be entered against the Defendants in an amount to be trebled to the extent such laws permit;
- D. Plaintiffs and the members of the Damages Class recover damages, to the maximum extent allowed by such laws, in the form of restitution and/or disgorgement of profits unlawfully gained from them;
- E. The Defendants, their affiliates, successors, transferees, assignees and other officers, directors, partners, agents and employees thereof, and all other persons acting or claiming to act on their behalf or in concert with them, be permanently enjoined and restrained

from in any manner continuing, maintaining or renewing the conduct, contract, conspiracy, or combination alleged herein, or from entering into any other contract, conspiracy, or combination having a similar purpose or effect, and from adopting or following any practice, plan, program, or device having a similar purpose or effect;

- F. Plaintiffs and the members of the Damages Class be awarded restitution, including disgorgement of profits the Defendants obtained as a result of their acts of unfair competition;
- G. Plaintiffs and the members of the Classes be awarded pre- and post- judgment interest as provided by law, and that such interest be awarded at the highest legal rate from and after the date of service of this Complaint;
- H. Plaintiffs and the members of the Classes recover their costs of suit, including reasonable attorneys' fees, as provided by law; and
- I. Plaintiffs and members of the Classes have such other and further relief as the case may require and the Court may deem just and proper.
